

COUNCIL SYNOPSIS

August 4, 2015

At the regular meeting of August 4, 2015, City Council made the following resolutions to:

- accept for information the following report included in the Consent Agenda:
 - Growth Management Implementation Strategy
- accept the presentation on the Yankee Valley Boulevard Traffic Signal Corridor Study for information.
- defeat Bylaw No. B-18/2015, being a bylaw to amend the Northwest Community Area Structure Plan.
- defeat Bylaw No. B-19/2015, being a bylaw to amend the Reunion Neighbourhood Structure Plan.
- defeat Bylaw No. B-20/2015, being a bylaw to amend Land Use Bylaw No. B-09/2005 by re-designating 12.34 acres from Direct Control 28 District (DC-28) to Residential Single Dwelling Small Lot District (R-1S), Residential Single Dwelling Small Lot Laned District (R-1SL), Residential Two Dwelling District (R-2) and Public Service District (P-1) for the subject parcel Lot 20, Block 1, Plan 071 4778 within the neighbourhood of Reunion.
- pass Bylaw No. B-21/2015, being a bylaw to amend the West Airdrie Community Area Structure Plan.
- pass Bylaw No. B-22/2015, being a bylaw to amend the Bayview/Bayside Stage 3 Neighbourhood Structure Plan.
- pass Bylaw No. B-23/2015, being a bylaw to amend Land Use Bylaw B-09/2005 by re-designating a total of 8.22ha (20.33ac) from Urban Holding District (UH) to Residential Single-Dwelling Small Lot District (R-1S), Residential Single Dwelling Narrow Lot District (R-1N), Residential Two Dwelling District (R-2), Residential Medium Density Multi-Dwelling District (R-4) and Public Service District (P-1) within the neighbourhood of Bayview/Bayside.
- pass Bylaw No. B-16/2015, being a bylaw to amend the Hillcrest Neighbourhood Structure Plan.

- pass Bylaw No. B-17/2015, being a bylaw to amend Land Use Bylaw No. B-09/2005 by re-designating a total of 4.71ha (11.64ac) from Urban Holding District (UH) to Residential Medium Density Multi-Dwelling District (R-4), Residential Back-to-Back Townhome District (R-BTB) and Public Service District (P-1) within the neighbourhood of Hillcrest.
- pass Bylaw No. B-39/2015, being a bylaw to amend Section 5-2 (3) of Land Use Bylaw No. B-09/2005 by adding “*Veterinary Clinic*” as a Discretionary Use in the Central Business District (CB).
- defeat Bylaw No. B-34/2015, being a bylaw to amend Section 5-2 (3) of Land Use Bylaw No. B-09/2005 by adding “*Veterinary Clinic*” as a Discretionary Use in the Central Business District (CB) specifically for Unit 3, Condo Plan 131 1195 (5117, 403 Mackenzie Way SW).
- defeat Bylaw No. B-36/2015, being a bylaw to amend Section 5-2 (3) of Land Use Bylaw No. B-09/2005 by adding “*Veterinary Clinic*” as a Discretionary Use in the Central Business District (CB) specifically for Lot 5, Block 1, Plan 101 4850 (1105, 35 Mackenzie Way SW).
- proclaim September 2015 as Prostate Cancer Awareness month in Airdrie.
- proclaim October 7, 2015 as Trigeminal Neuralgia Awareness Day and direct staff to light up City Hall in teal coloured lights to show support for the third annual event.
- direct staff to file the correspondence.
