ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF TOMS RIVER, OCEAN COUNTY, NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 321

## (GAMES OF CHANCE) OF THE TOWNSHIP CODE TO ESTABLISH LICENSING PROCEDURES AND FEES FOR AMUSEMENT GAMES

**WHEREAS,** at the general election held in November, 1959, New Jersey voters approved, in a statewide referendum, the Amusement Games Licensing Law, <u>N.J.S.A.</u> 5:8-78 to -120, permitting municipalities allow amusement games by local ordinance;

**WHEREAS**, under this law, amusement games are permitted (1) in municipalities that voted in favor of the Amusement Games Licensing Law; and (2) in recognized amusement parks, or in designated amusement or entertainment areas in seashore or other resort communities; and

**WHEREAS**, the Township of Toms River (then the Township of Dover) voted in favor of the Amusement Games Licensing Law; and

**WHEREAS,** the barrier island sections of the Township qualify as seashore or resort areas in which designated amusement or entertainment zones can be established; and

WHEREAS, in accordance with state law, the Township Council intends to establish an amusement/entertainment area in the barrier island section of Township and a licensing procedure so that arcades and other amusement game establishments can continue to operate lawfully:

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Toms River, Ocean County, New Jersey, as follows:

1. Chapter 321 (Games of Chance) is hereby retitled as "Games of Chance and Amusement Games" and amended and supplemented as follows:

## §321-19. Amusement Games.

- A. <u>Amusement Area Defined</u>. It is hereby determined, declared and found that this municipality constitutes a seashore resort with parts thereof customarily constituting an amusement or entertainment area according to the customary understanding of said terms in the community, and which said parts thereof are more particularly described as follows: the area immediately along the easterly side of State Highway 35 North between First and Sixth Avenues.
- B. License Required. It shall be unlawful for any person, firm or corporation to own or operate within this municipality any amusement game or games, as said terms are defined by said "Amusement Games Licensing Law" (Chapter 109, P.L. 1959), whether said game or games are of skill or chance, or both, and whether said game or games be played and operated with or without numbers or figures, without first having obtained a license to do so. Said license shall be issued pursuant to and subject to the provisions of "Amusement Games Licensing Law" (Chapter 109, P.L. 1959).

## C. <u>Application for License.</u>

- 1. Each applicant for a license shall file with the Township Clerk a written application in such form as prescribed by and in accordance with the Amusement Games Licensing Law, as amended and supplemented, and the rules and regulations promulgated by the Amusement Games Control Commissioner of the State of New Jersey.
- 2. The background and qualifications of each applicant shall be investigated following the filing of the application. A license shall only be issued if the applicant satisfies the criteria set forth in <u>N.J.S.A.</u> 5:8-103.

- D. <u>License Term.</u> Licenses issued pursuant to this section shall be valid for one year from January 1 through December 31 and must be renewed annually.
- E. <u>License Fee.</u> The annual fee for an amusement game license shall be \$650.
- F. <u>Loud Noises; Amplifiers.</u> No loud sounds or noise shall emanate from buildings where the aforesaid games are conducted, and all amplifiers must face inside the building so that the sound will not be heard outside of the building.
- G. <u>Identification Card; Fee.</u> Each applicant and applicant employee shall be fingerprinted, registered and issued identification cards under the rules and regulations promulgated by the Amusement Games Control Commissioner for each licensee and employee of said licensee. Any fees associated with the fingerprinting, registration, and issuance of identification cards are the responsibility of the applicant.
- H. <u>Control and Supervision</u>. The Mayor and Council of the Township of Toms River shall have and exercise control and supervision over all amusement games held, operated or conducted under such license, with all the powers authorized or granted to them under the Amusement Games Licensing Law, any and all amendments and supplements thereto, and the rules and regulations of the State Amusement Games Control Commissioner.
- I. <u>Suspension/Revocation</u>. Licenses are subject to suspension or revocation, or both, for violations any of the provisions of this chapter, the Amusement Games Licensing Law, the rules and regulations promulgated by the State Amusement Games Control Commissioner, or the terms of licenses issued pursuant to this chapter.
- J. <u>Hearing</u>. Pursuant to <u>N.J.S.A.</u> 5:8-104 and <u>N.J.S.A.</u> 5:8-106, no licensee shall be denied without a hearing being held before the Township Council, or its designee, on due notice to the applicant or licensee.
- K. <u>Violations and Penalties.</u> Any person or entity violating this section, or the terms and conditions of any license issued pursuant hereto, shall be subject to the maximum fines and penalties established under <u>N.J.S.A.</u> 40:49-5 and <u>N.J.S.A.</u> 40:69A-29, and any subsequent amendments to those statutes. Each and every day a violation of this Chapter persists shall constitute a separate violation.

2. All other provisions of Chapter 321 remain in full force and effect.

3. All ordinances or parts of ordinances which are inconsistent herewith are repealed, but only to the extent of the inconsistency.

4. If any part of this ordinance is invalidated for any reason by competent authority, that part is severed and the remaining provisions shall remain in full force and effect.

5. This ordinance shall take effect following its final passage by the Township Council, approval by the Mayor, and twenty days after publication as required by law.

This Solid Waste Collection Agreement ("Agreement") is entered into this \_\_\_\_\_\_day of \_\_\_\_\_\_, 2014, between the Township of Toms River ("Township" or "Toms River"), a municipal corporation established and operating under the laws of the State of New Jersey, with offices located at 33 Washington Street, Toms River, New Jersey, 08753, and Autumn Ridge at Toms River Condominium Association ("Autumn Ridge"), c/o Homes for All, 7 Hyers Street, Toms River, New Jersey, 08753 ("Homes for All"), for the purpose of arranging for the collection and disposal of solid waste and recyclable materials.

# **RECITALS**

WHEREAS, Autumn Ridge is a qualified private community under the Municipal Services Act ("MSA"), <u>N.J.S.A.</u> 40:67-23.01 to -23.8, managed and operated by Homes for All; and

**WHEREAS**, under the MSA, the Township must either directly provide solid waste collection to qualified private communities or reimburse private communities for the expense of that service at a rate equal to the Township's actual cost of providing solid waste collection to the general public; and

WHEREAS, the Township has determined that it is more efficient and cost-effective to directly provide solid waste collection to Autumn Ridge, rather than reimburse the costs of those services; and

**WHEREAS**, Autumn Ridge and Homes for All agree with the Township's determination and have requested and consented to Township-provided solid waste collection:

The parties hereby agree as follows:

**1.** <u>Services and Materials Provided</u>. The Toms River Township Department of Public Works ("DPW") will provide the following services and materials to Autumn Ridge:

- a. Regular collections of household solid waste once weekly and single stream recyclable materials on a twice-per month basis. Collection days will be compatible with existing DPW routes on mutually-agreed upon dates.
- b. One recycling container and one trash container (95 gal.) are required for each of the association's 49 units. The association shall purchase these containers from the Township, in one bulk order at the cost established by ordinance of \$100 per container.
- c. DPW will coordinate delivery of containers to specific addresses within the community, with assistance of the Association.

**2.** <u>**Cost**</u>. Unless otherwise stated, the Township will provide services listed in the preceding paragraph at no cost to Autumn Ridge.

**3.** <u>**Prohibited Materials**</u>. The Township shall not collect construction or demolition debris, hazardous materials, and any other debris prohibited by ordinance.

**4.** <u>Insurance Required</u>. Pursuant to <u>N.J.S.A.</u> 40:67-23.4, Autumn Ridge must submit a current valid insurance policy or rider, naming the Township, and its employees, agents, assigns, and successors as insured parties, in the amount of \$300,000/\$1,000,000. A current insurance policy or rider must be submitted annually and is subject to review and approval by the Toms River Township Division of Law.

5. <u>Proper Authority</u>. Both parties represent that this agreement has been approved in accordance with each other's applicable rules and procedures and has been executed by persons with the proper authority to do so.
